**ORDER**

Upon consideration of Plaintiffs’ Unopposed Motion for Approval of Further Distribution of Settlement Funds to the Collective and Reimbursement of Reasonable Litigation Costs Inadvertently Omitted from Prior Accounting (Doc. 290), and good cause appearing,

**IT IS ORDERED** the Motion for Approval of Further Distribution (Doc. 290) is **GRANTED**. The Settlement Administrator shall undertake additional efforts to locate Collective Members and make additional distributions of settlement funds to Collective Members, as more specifically described in Plaintiffs’ Motion and in the Declaration of the Settlement Administrator filed therewith, such that the residual funds remaining in the collective action settlement fund can be distributed to Collective Members before the residual is donated to *cy pres*.

**IT IS FURTHER ORDERED** the Court approves payment to the Settlement Administrator for the additional administrative costs associated with performing the additional address research and settlement distributions, estimated to be \$47,414.00, as


1 specified in the Declaration of the Settlement Administrator, to be paid out of the settlement  
2 fund.

3 **IT IS FURTHER ORDERED** the Court approves payment of \$9,990.90 to  
4 Plaintiffs' Counsel out of the settlement fund, for out-of-pocket costs that they reasonably  
5 incurred during the litigation, but inadvertently omitted from the cost bill previously  
6 submitted to the Court with the original motion for attorneys' fees and costs.

7 **IT IS FURTHER ORDERED** the Court approves payment of the residual  
8 remaining in the settlement fund, after completion of the foregoing, to the designated *cy*  
9 *pres* recipient, The University of Arizona James Rogers College of Law Workers' Rights  
10 Clinic, in accordance with Paragraph 31 of the Settlement Agreement (Doc. 282-1) at  
11 Exhibit 1, and the Court's Order approving the Settlement (Doc. 288).
